

Declaration of terms and conditions of use of the Educoach Website's services

By accepting the terms and conditions below, you declare that:

I- Educoach S.A., hereinafter referred to as "Educoach", may process your personal data to the limited extent of that which may be appropriate and relevant to what is necessary for the fulfillment of emerging legal obligations, with consent from the website's user for this purpose.

II- The information and authorization mentioned in the previous number include the use and processing of personal data for contact, administrative and financial purposes, pedagogical management, human resources recruitment and processing of documentation certificative of pedagogical activity.

III - The information and consent in numbers I to II were preceded by information explicitly, concretely and freely provided.

IV- Acknowledges the commitment of Educoach to maintain the confidentiality of all personal data provided through the contact form or any other means of communication on the Educoach Website, not using that data for personal and / or commercial purposes.

V- Educoach may collect cookies on your website to improve the navigation experience and anonymous browsing data through external software used for this purpose, to the extent that the user gives his consent for this purpose.

VI- Is fully aware:

OF THE CONCEPT: The concept of personal data covers any information relating to a natural person, identified or identifiable, directly or indirectly, in particular by reference to an identifier, such as a name, an identification number, location data, electronic identifiers or to one or more elements of physical, physiological, genetic, mental, economic, cultural or social identity of that individual.

OF THE NEED: The communication and processing of your personal data as provided in II, are a mandatory requirement for the conclusion and execution of the service and compliance with legal obligations arising therefrom.

OF UPDATED INFO AND ACCURACY: Your personal data must be accurately communicated, in particular through the means of contact on the Educoach website, whereby the declarant has to keep Educoach informed of any changes in said data, in order to allow its removal or rectification without delay and in full compliance with all data protection legislation.

THE LIMITATION OF PURPOSES AND CONSERVATION: Your personal data cannot be treated in a way that is incompatible with the purposes mentioned above, without prejudice to its subsequent processing for archival purposes, always in accordance with legal guarantees. Your personal data will be kept for the period necessary for the purposes for which they are processed, that is, for the entire period of validity and at least until a period of three (3) years after the end of the validity period, except in cases where legal proceedings might be under way in which personal data may be used, or in which the data must be obligatorily maintained in accordance with the legislation in force.

OF RIGHTS:

That you have the right to ask the person in charge of Educoach to forget your personal data, as well as to rectify it ("right to be forgotten").

That you have the right to receive your personal data concerning you and to transmit this data to another person responsible for handling it ("Portability").

That you have the right to have Educoach and / or any partner entity, pursuant to number III, transmitting your personal data, adopt and apply appropriate technical and organizational measures to ensure a level of protection against unauthorized or unlawful use and / or against its loss, destruction or accidental damage.

That you have the right to oppose the processing of your data.

You have the right to rectification, limitation, processing or deletion of your personal data.

That you have the right to be informed without undue delay when a breach of personal data is likely to involve a high risk to your rights and personal freedoms.

You have the right to complain to the supervisory authorities.

You have the right to know the name (s) and contact (s) of the person (s) responsible for the processing of personal data and data protection.
